3. Urban dimension in the legislative package for cohesion policy after 2013.

Members were informed about the provisions concerning cities in single regulations from the legislative package for cohesion policy 2014-2020 (extract of the legal texts from the regulations on common and general provisions, on the ERDF, on the ESF and on the territorial cooperation was provided for the members). Mr. Olbrycht presented briefly all the relevant articles; Mme Manescu, Mme Sanchez-Schmid and Mr. van Nistelrooij commented on the legal texts in their capacity of rapporteurs or shadow rapporteurs for EP reports. The presentation was followed by the first exchange of views between members. The mail points of the discussion included such issues as: list of cities (criteria for selection of cities in MS, definition of city, city <-> metropolitan area/agglomeration), models for the integrated approach, multi-fund OPs, PPPs, financial instruments.
