needed? How should they interact with the authorities? How to evaluate their effectiveness and what value added

does the EU offer?

Three case-studies will demonstrate the shared responsibilities of public and private stakeholders and examine

keys for success.

Policy, practice and evidence - delivering results in urban mobility through interregional cooperation

Brief: In today's climate of budget reductions and increasing pressure to deliver cost-effective policies, policymakers need access to tried and tested methods and evidence of successful practices. Territorial cooperation

programmes (ESPON, INTERACT, INTERREG IVC and URBACT) can provide tools to help cities and regions

improve their performance. This panel session will showcase the direct benefits for sustainable mobility in the

cities of tomorrow and how Green Growth is intricately linked with viable smart transport systems.

The INTERREG IVC and URBACT programmes – funding exchange of experience on regional and urban level – will demonstrate their past impact and future potential in delivering results. The individual experience of two project partners, from old and new member states, will illustrate the direct impacts on their own integrated mobility planning from the exchange of experience process.

In addition, an exclusive preview of capitalisation work will be presented. Experts will give examples of the knowledge created and how it can be transferred to and exploited by other cities and regions across Europe.

With innovative new findings related to transport accessibility at regional/local scale and patterns across Europe, ESPON will demonstrate its contribution to the evidence base for policy-makers in making informed decisions. Finally, the INTERACT programme will provide an overview of cross-border and transnational strands of European Territorial Cooperation with respect to sustainable mobility.

This panel will explore how exchange of policy experience combined with territorial evidence data can create added value European networking to enable regions and cities to deliver results and achieve EU 2020 goals.

Be SMART-think CITY!- How to match smartness, sustainability and inclusion in governing Europe of tomorrow?

Brief: Within the next Multiannual Financial Framework new opportunities for cities in post 2013 perspective will be available. A number of modern instruments shall be provided for regional and local authorities in order to facilitate sustainable and integrated development of urban areas. Moreover, effective urban performance is to be achieved only by holistic problem-solving approaches. Therefore, it is the right time to start preparation towards practical implementation of already defined attributes of SMART CITIES. Our multidisciplinary debate will give the participants opportunity to discuss breakthrough solutions towards the 'traditional' concept of Smart Cities (e.g. ICT solutions, clean transport, energy efficiency) as well as addressing societal and environmental challenges (health, active aging, education, water scarcity). All these elements can not be separated when achieving goals of the strategy Europe 2020, Cohesion Policy and Horizon 2020 in an integrated manner.

Debate 'URBELAC network: exchanging best practice on sustainable urban development between Europe and Latin America'

Brief: Through the URBELAC (Urban European and Latin American and Caribbean Cities) network supported by the European Commission (Directorate-General for Regional Policy) and the Inter-American Development Bank, Latin American and European cities have begun exchanges of best practice on urban development topics as urban revitalization, mobility, environment, and education.

URBELAC, through round tables, working groups, field visits and permanent exchanges, is a platform to encourage direct exchanges between cities facing similar problems by sharing information, best practices and lessons learnt; and to facilitate the identification of a common set of indicators needed to measure the impacts on

sustainable development and to conceptualize integrated development processes of cities according to the guidelines for sustainability. This workshop will focus on what activities have been carried out, with presentations on urban development issues from Europe and Latin America.

Climate change adaption and EU cities

Organisers: European Commission, DG CLIMA C3, European Commission, DG REGIO C2

Brief: Climate mitigation and adaptation is an increasingly important part of urban development policies, and cities in Europe are considered key for the implementation of these policies and achieving effective climate adaptation. Cities are already adapting but, according to the European Environment Agency (EEA), still in a piecemeal manner. More integrated and systematic approaches are needed that understand adaptation efforts not only as a disaster risk response, but as an opportunity for upgrading urban systems – technical, institutional and societal. Understood that way, climate adaptation can offer a stepping stone to develop resilient and sustainable cities and regions supporting the Europe 2020 strategy goals of smart, sustainable and inclusive growth.

The session will address the challenges, opportunities and ingredients, when developing integrated approaches to climate adaptation at the local level. The expected outcome of the session is an increased understanding of the success factors and barriers in effective and efficient mainstreaming of climate adaptation into urban development in European cities.

The session will be organised as a panel discussion, with the interaction of participants a key feature. The facilitator will introduce the topic and outline the dimensions of local climate adaptation. The discussion will be implemented in three rounds, with a particular focus: challenges & barriers, opportunities, and success factors.

The workshop will be supported by a major Directorate-General for Climate Action (DG CLIMA) project 'Adaptations strategies in EU cities' and held in cooperation with both the EEA and the Metropolitan Research Institute Budapest, the main contributor to the handbook 'Climate-friendly cities'. It will be co-chaired by the Directorate-General for Regional Policy (DG REGIO) and DG CLIMA. As panellists, participating cities to the Covenant of Mayors are foreseen, such as climate change managers from the cities of Ancona (IT), Helsinki (FI), Birmingham (UK), London (UK) and/or Copenhagen (DK).

The debate will furthermore focus on and how Cohesion Policy can contributes to all this. Innovative regions and cities for territorial development

Followed by networking event

Organisers: Committee of the Regions, Political Group European People's Party (EPP)

Brief: In order to achieve the objectives of the Europe 2020 strategy, we have to focus more on innovation and research, while taking account of the innovation potential of regions and cities. It is therefore essential that regional politicians and policy-makers, as well as locally-based universities and research institutes begin to actively develop joint regional innovation strategies based on smart specialisation. In addition, the EU, national and regional research and innovation agendas must be coordinated.

A particular attention should be also paid to various financing sources, including regional and local budgets, business contributions and a number of EU financial instruments. For instance, EU cohesion policy and Horizon 2020 contribute to enhancing the skills and innovation capacity, as well as to developing instruments and cooperation that promote intra-European cooperation between regions.

EPP/CoR Group continues its contribution to the implementation of the EUROPE 2020 strategy, in the context of future Cohesion Policy 2014-2020. This year's workshop will focus on the Innovation Union flagship initiative, assessed from various angles such as: energy efficiency, SMEs and modernising public administration.

In addition the workshop will also showcase best practices in these fields and will be followed by a networking session.

The key findings of the debate will be documented on-line during the workshop and the participants will interact as well by voting to define the most relevant outcomes. This will facilitate the discussion at the networking event (Atrium 5, COR) that will follow the workshop.

How can EU cohesion policy funds support the activities of Covenant of Mayors signatories?

Followed by networking event

Organisers: Committee of the Regions, Europe 2020 Monitoring Platform - Covenant of Mayors Office, Covenant of Mayors Office, European Green Capital Award

Brief: Local and regional authorities see both the urgency and the opportunity to reinforce their commitment to Europe's recovery by investing in sustainable energy. To achieve the ambitious goal of meeting and exceeding the EU target of a 20% reduction in CO2 emissions by 2020, local and regional governments should be supported in gaining access to finance. The panelists and the audience will discuss the importance of EU funding and innovative financing schemes to ensure the success and expansion of the Covenant of Mayors initiative. While the Covenant's focus on energy is fundamental, efficient use of resources is also important and many Covenant signatories already act in this field.

The debate will bring together signatories of the Covenant of Mayors, European Green Capitals finalists, Members of the Committee of the Region and representatives of the European Commission. Questions to be discussed include: How can the EU institutions support signatories in their efforts? How can cohesion policy funds be used to implement local sustainable energy policies? How can the Covenant be extended geographically and thematically?

Fostering a better governance of territorial integration of urban areas

Brief: Europe faces strong challenges with regard to the economic and financial crisis which affects public budgets and cities' budgets. Competition between cities may be a zero-sum game or even be detrimental to regional development. Cities' ability to contribute to Europe 2020 strategy objectives calls for a better integration of urban areas and joint work between cities. Governance is a core challenge in this context.

Both research work and practical examples will be presented in this workshop, illustrating how new forms of governance may foster this integration and positively impact on cities' performances, and the main principles that could be applied. Results of projects or studies funded under the URBACT programme, the European Urban Knowledge Network (EUKN) and the EMI institute will be presented with a view to bridging the gap between current research and findings – based on European cooperation or comparative analysis – and the broader

usability of these by practitioners. The workshop will leave time for interactions with the audience in order to discuss questions and issues at stake in this context.

- Territorial integration of urban areas;

New forms of multi-level governance for polycentric urban areas and cities' networks; and

- Connecting cities through new forms of partnerships.

Cities of tomorrow: Urban futures in a changing world

Organisers: The Joint Programming Initiative (JPI) Urban Europe

Brief: The future of Europe will be decided in its cities. Today, a majority of Europe's population lives in urban regions that generate a large portion of our welfare. They are engaged in a worldwide competition for quality of life, productivity and communications; they compete for investments and the 'best brains'. At the same time, they confront us with environmental damage, urban sprawl, problems of urban traffic and transport, social cohesion issues, including segregation of migratory groups, security problems, and the need to adapt to the climate change.

In trying to address global urban challenges and joint European solutions, the research Joint Programming Initiative (JPI) Urban Europe has set up a forward-looking activity that aims at partnering up with China in

identifying the megatrends driving the urban dynamics in both Europe and Asia. A reflection process was also launched by DG REGIO in 2010 on 'Cities of Tomorrow' that formed a part of the wider discussions on the future of regional policy and how it can support towns and cities to tackle the challenges of today. The workshop will build on and address the cornerstones of these developments and bring together top experts from both Europe and Asia for a scientific debate on urban futures in a changing world with high relevance for and attention to cohesion policy.

The JPI Urban Europe is a Member State-led initiative that coordinates the urban-related research programmes of the participating countries in order to exploit synergies between the national research programmes and European ones. The initiative will elaborate a Strategic Research Agenda and implement it through multi-annual joint actions and calls for proposals. The JPI Urban Europe represents a forward-looking research initiative with an integrated approach to sustainable urban development across its research interfaces of economy and innovation, mobility, society and ecology.
